Rental Policies

- Standard hours of operation are 8am to 12am.
- Rental rates listed are for 24-hour period of single units.
- Rental periods begin at 8am, 10am, Noon, 2pm, 4pm, 6pm, 8pm, or 10pm.
- A two (2) hour pickup window, starting at these times, will be assigned at the time of rental agreement.
- Multiple-day rentals are not guaranteed, but may be available. The multi-day rental discounts are as follow:
 - (a) 3-day rentals will have a 15% discount applied.
 - (b) 4-day rentals will have a 20% discount applied.
 - (c) 5-day rentals will have a 25% discount applied.
- Equipment rentals require payment in full for the reservation period to be confirmed.
- Rental costs are refundable as follows:
 - (a) The rental cost is **FULLY REFUNDABLE** if notice is given **72+ hours** prior to the scheduled rental period start-time,
 - (b) 50% refund of the rental cost if notice is given **less than 72 hours, but more than 24 hours**, prior to the scheduled rental period start-time,
 - (c) If the client **fails to provide notice of rental cancellation more than 24 hours** prior to the scheduled rental period start-time, then the **rental cost is forfeited in full.**

No exceptions will be considered as your equipment rental confirmation has precluded other clientele from utilizing the same equipment during the period of time reserved.

- A minimum rental booking of \$25 is in place.
- The studio certifies that the rental equipment in question will be fully functional at the time of physical transfer to the client.
- The client certifies that the rental equipment in question will be used exclusively by the client and that their rental is not transferable to others.
- The studio alone reserves the right, at the time of rental, to assign a 'dedicated operator' for the purposes of liability of the rental equipment in addition to the client.
- The client certifies that they will be liable for the associated repair or insured replacement costs in the event of damage to, or theft of, the rental equipment in question.
- The client certifies that the rental equipment in question will be prepared for return to the studio at the end of the booked rental period.
- The client certifies that the rental equipment in question is exclusively for use at the agreed upon rental location.
- The client certifies that they will be responsible for any legal or collections fees the studio may accrue in the event of their failure to compensate the studio for damage to the associated rental equipment.
- The client certifies that failure to pick-up the equipment within the agreed upon time window will result in automatic cancellation of the rental and full forfeiture of the deposit.
- Client certifies that extension of the rental period is the sole discretion of the studio as is not guaranteed.
- Rentals that must be booked with less than twenty-four (24) hours' notice to the scheduled start time will have a 20% surcharge applied.
- Studio accepts Venmo, Zelle, Google Wallet, Cash, Credit/Debit Cards, ACH & PayPal. Any usage fees (ex. PayPal's service charge) are added as cost to the rental fee. *The studio reserves the right to charge a penalty fee for late payments toward client invoices and scheduled payments. Non-payment past the invoice due date will yield a 5% penalty fee on the gross invoice sub-total.*
- The studio reserves the right to request the following documentation prior to approval of equipment rentals: A government ID; a scan of credit/debit card; a fully executed transaction agreement for the aforementioned credit/debit card.
- The client accepts that initial receipt of this, and any other, studio term-sheet(s), and the completion of the required rental deposit payment(s) will be tantamount to a legally binding signature.

In order to maintain maximum production output and accessibility of the studio to its clientele the listed policies are, under no circumstances, open to negotiation and will, without exception, be enforced in full.
